DECLARATION OF CONFORMITY

Product	Corrugated cardboard and packaging with flexographic and offset print
Product purpose	For collective packaging, not intended for direct contact with food


Werner Kenkel Spółka z o.o. hereby declares, that the offered product:

- a) Is compliant with Regulation (EC) No 1935/2004 of the European Parliament and of the Council of 27 October 2004 on materials and articles intended to come into contact with food and repealing Directives 80/590/EEC and 89/109/EEC, apart from requirements relating to food contact migration,
- b) Is compliant with Commission Regulation (EC) No 2023/2006 of 22 December 2006 on good manufacturing practice for materials and articles intended to come into contact with food
- c) Is compliant with the EuPIA Guideline for Food Packaging Inks, on the side not intended for contact with food.
- d) Is compliant with Regulation (EC) No 1907/2006 of the European Parliament and of the Council of 18 December 2006 concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH), establishing a European Chemicals Agency, amending Directive 1999/45/EC and repealing Council Regulation (EEC) No 793/93 and Commission Regulation (EC) No 1488/94 as well as Council Directive 76/769/EEC and Commission Directives 91/155/EEC, 93/67/EEC, 93/105/EC and 2000/21/EC
- e) Is compliant with Directive 94/62/EC of the European Parliament and of the Council of 20 December 1994 on packaging and packaging waste
- f) Is not intended for direct contact with food,
- g) Is compliant with the Act of 13 June 2013 on management of waste and packaging waste (Journal of Laws 2013, item. 888), in particular:
 - Regulation of the Minister of the Environment of 21 January 2015 on the method of determining the total content of lead, cadmium, mercury and hexavalent chromium in packaging (Journal of Laws 2015, item 170),
 - Regulation of the Ministry of the Environment of 21 January 2015 on packaging for which the requirements relating to the content of lead, cadmium, mercury and hexavalent chromium in packaging, are not applicable (Journal of Laws 2015, item 137).
- h) In the packaging production process, phthalates, bisphenol and mineral oils MOSH / MOAH are not intentionally added; however, trace amounts of phthalates and mineral oils MOSH / MOAH, the level of which can not be guaranteed, can come from waste paper used to paper.
- i) The cardboard is adapted to temperature -18 degrees of Celsius under condition that a constant minus temperature is maintained throughout the chain from the packaging process to delivery to the final customer.
